

Abayomi Connect – Terms & Conditions

Last updated: February 2026

These Terms & Conditions (“Terms”) govern access to and use of the Abayomi Connect platform (“Platform”), operated by Abayomi (“Company,” “we,” “our,” or “us”).

By creating an account, purchasing credits, offering or hiring services, or participating in Community Exchange Services, you acknowledge that you have read, understood, and agree to be legally bound by these Terms.

1. Platform Role and Disclaimer

Abayomi Connect is a digital marketplace and community platform that facilitates connections between independent service providers (“Vendors”) and individuals or entities seeking services (“Clients”).

Abayomi does not provide, supervise, manage, endorse, guarantee, or insure any services listed or performed through the Platform.

All services are offered and performed solely by independent third parties. Abayomi is not an employer, agent, partner, joint venture, or insurer of any Vendor and does not control how services are delivered.

2. User Accounts

Users may register as Clients, Vendors, or both.

You are responsible for maintaining accurate, current, and complete account information and for safeguarding your login credentials. You agree not to share your account or allow unauthorized access.

By creating an account, you confirm that you are at least 18 years old and legally capable of entering into binding agreements.

3. Vendor Responsibilities and Compliance

Vendors operate as independent contractors and are solely responsible for the services they offer and perform.

Vendors are responsible for:

Holding and maintaining all required local, state, national, or international licenses, permits, certifications, and approvals

Maintaining any required insurance coverage

Accurately disclosing credentials, licenses, geographic limitations, and service conditions in their profiles

Complying with all applicable laws and regulations

Abayomi does not verify licenses, credentials, or insurance and disclaims all responsibility related thereto.

4. Client Responsibilities

Clients are responsible for reviewing vendor profiles, service descriptions, credentials, and disclosed limitations before purchasing services.

Clients acknowledge that they are solely responsible for determining whether a Vendor is suitable for their needs, including verifying licensing, insurance, and compliance where applicable.

Abayomi acts solely as an intermediary and does not guarantee service outcomes, quality, or suitability.

5. Credits and Payments

Credits represent prepaid access to services available on the Platform.

Credits:

Have no cash value

Are non-refundable except as required by law

Must be redeemed using a single-use credit code

Are redeemed in full at checkout (no partial balances or carryover)

Vendor payouts are processed via PayPal within up to seven (7) business days after a service is marked as "Completed," subject to payment confirmation, dispute review, fraud prevention checks, and compliance verification.

6. Community Exchange Services (CES)

Community Exchange Services ("CES") are non-monetary service exchanges designed to support community vitality and mutual support.

CES Credits:

Are earned through verified community service activity

Are valid only within the Community Exchange category

Have no cash value

Are not redeemable for USD or other currency

May be shared voluntarily but may not be sold, traded, or exchanged for money

Abuse, manipulation, or simulated service activity may result in suspension, loss of credits, or termination of accounts.

7. Scheduling and Service Completion

After a service is purchased, Vendors and Clients are expected to coordinate scheduling directly within twenty-four (24) hours unless otherwise agreed.

Vendors must mark services as “Completed” in the Platform once the service has been fully delivered. Failure to do so may delay or prevent payout processing.

8. Marketplace Fees and Commission

Abayomi Connect operates as a marketplace that connects Clients with independent Vendors.

Clients pay only the published service price through the Abayomi credit system. No additional platform or service fees are charged to Clients beyond the price displayed at checkout.

Abayomi Connect charges a commission to Vendors only on completed paid services sold through the Platform. Vendor commissions are deducted automatically before payout.

Commission rates may be updated with prior notice to Vendors.

9. Reviews and Community Trust

Users are encouraged to leave honest, respectful, and factual reviews following service completion.

Reviews must not contain false, misleading, abusive, discriminatory, or defamatory content.

Abayomi reserves the right, but not the obligation, to remove reviews that violate platform guidelines or community standards.

10. Anti-Abuse and Fraud Prevention

Abayomi actively monitors platform activity to prevent fraud, misuse of credits, manipulation of Community Exchange Services, or other abusive behavior.

Any attempt to fabricate, misrepresent, or simulate services or transactions may result in suspension, forfeiture of credits, withheld payouts, or account termination, at Abayomi's sole discretion.

11. Limitation of Liability

To the fullest extent permitted by law, Abayomi disclaims all liability related to services performed by Vendors, including but not limited to personal injury, property damage, service quality, delays, or disputes.

Abayomi is not responsible for the actions, omissions, or representations made by Vendors or Clients.

12. Indemnification

You agree to indemnify, defend, and hold harmless Abayomi, its officers, directors, employees, affiliates, and partners from any claims, damages, losses, liabilities, or expenses arising from your use of the Platform, services offered or received, or violation of these Terms.

13. Governing Law

These Terms are governed by and construed in accordance with the laws of the United States and the State of Florida, without regard to conflict of law principles.
